Bylaws

April 2024

Article I – Name

The name of this organization shall be the Kennedy Space Center Golf Club (KSCGC).

Article II – Objective

The objective of the club shall be to promote a fun/competitive environment where golfers within the KSC community can come together to play while creating new connections with the KSC ecosystem. This objective shall be reached by maintaining a list of people interested in joining a league with a schedule of local courses within Brevard County and engaging them through regular events.

Article III – Membership

Section 1	There shall be one class of membership: full membership. Full membership is an unrestricted membership with all rights and privileges. All full members must be KSC employees (including contractors) with a valid PIV or similar security badge.
Section 2	Member participation in club activities is entirely voluntary. Participation in club activities is not required to maintain membership
Section 3	Members may invite guests of their choosing ages 13+, for any events that KSCGC host. League play will be exclusively for members who are KSC employees (Including contractors).

Article IV – Dues

Dues will be determined at the beginning of each league (How many sessions and associated cost is TBD) in accordance with local golf course rates (Green fees, Carts, Rental Clubs, etc.).

Article V – Resignation, Expulsion, and Reinstatement

Section 1	Any member may resign their membership by notifying the League Commissioner or their Deputy Commissioner. To resign typically means that a member is no longer able to or is no longer interested in participating in club-related activities.
Section 2	Any member may be expelled from the club at the discretion of the League Commissioner or their Deputy Commissioner. This may occur if the member either is no longer available to participate in club-related activities or has been reported by at least two other members as having demonstrated behavior inconsistent with Article II
Section 3	Any member previously expelled may be reinstated at the discretion of the League Commissioner any time

Article VI – Records

Section 1	There are currently no financial records to be maintained by the club
Section 2	The League Commissioner/Deputy shall maintain a roster of all members with pertinent information related to current leagues/events

Article VII – Meeting Minutes

No meeting minutes will be maintained.

Article VIII – Nomination and Election of the Keeper of Records

Section 1	The league Commissioner and Deputy have been assigned as the founding members of this organization. Future meetings can be held if interest grows in which we will hold votes to elect other official positions within the organization including the Commissioner and Deputy.
Section 2	Any official positions within the organization shall serve until they no longer wish to hold the position or until a majority of members vote to replace them.

Article IX – Duties

Section 1	The League Commissioner/Deputy shall maintain the club records.
Section 2	The League Commissioner/Deputy shall be responsible for the club's public relations. This means from time to time the League Commissioner/Deputy and other volunteer members will disseminate information about the club to help recruit new members
Section 3	Members shall support the club activities to the best of their abilities. They should strive to conduct themselves in a manner which reflects credit upon themselves, the club, and Kennedy Space Center during and away from golfing activities

Article X – Amendments

Changes to these bylaws can be proposed by any active member or group of active members. An informal majority vote of the active members is sufficient to approve such changes.

Article XI – General Provisions

Section 1	The property and equipment purchased by or donated to this organization shall not be considered the property of any individual or group of members but shall be known as club property.
Section 2	No member or dependent of a member shall, by virtue of services rendered, be compensated because of these activities. Any use of the facilities or equipment owned by this organization for financial gain is prohibited

Article XII – Parliamentary Authority

The rules contained in Robert's Rules of Order shall govern the meetings and any instance not already addressed by these laws.
